107. Apologies for Absence

108. Minutes of the meeting held on Tuesday 10th November 2009 & the Budget meeting held on 24th November 2009

Cllr Hawkes proposed accepting the minutes from the meeting held on 10th November, Cllr White seconded the proposal, all in favour. The minutes were signed and dated as a true record. Cllr Spires proposed accepting the minutes from the Budget meeting held on 24th November, Cllr Evans seconded the proposal, all in favour. The minutes were signed and dated as a true record.

109 Code of Conduct Declaring an Interest.

Cllr Hawkes declared a personal interest in item 118 Lawling Park as her husband is employed by the council in this area.

Cllr White declared a personal interest under item 115. The Sea Wall.

110. Public Discussion Session.

The Chairman closed the meeting at 7.32pm to allow the D.Cllr and the public to address the council. D.Cllr Cussen reported on a planning application that has been deferred and other planning issues. MDC has not yet made a decision on a permanent replacement for their Chief Executive.

Four younger residents requested an extension to the skate park. It was suggested that they sent their designs and photographs to the council for consideration. There is no provision currently in the budget for an extension but a grant maybe possible.

Other residents spoke about press releases in the M & B which they were unhappy with. They also felt that this council is taking too much interest in their area of Mayland. The Chairman explained that the Parish Council takes an interest in all areas of Mayland and Maylandsea.

The Chairman reconvened the meeting at 8.13pm

The Chairman proposed moving item 115 Village Environment, the Sea Wall forward to allow D.Cllr Cussen to hear the information. Cllr Oatham seconded the proposal. For ease, the Sea Wall will be minuted in its original place on the agenda.

MDC's response to questions raised by Cllr Oatham at the budget meeting. MDC's Planning Dept., explained that permission was needed for a storage unit used by a third party. If the unit is being used by the Parish Council's staff then permission is not required..

115. Village Environment

Lighting, Cllrs reported that Mayflower Walk's light was not working. Also Cllr Oatham asked that the council write to ECC regarding the lights controlled by timers. These lights are going out at 11.45pm which could be a health and safety issue. **Clerk** to contact. Cllr Spires suggested we asked for some lights to remain on. The council believes this to be possible as the light at Esplanade/North Drive stays on all night.

Vandalism. Cllrs reported. The chain on the balance swing had been knotted, the mats around the roundabout had been removed and thrown around the area, a down drain pipe had been removed from the Lawling Park Hall and the drain filled with stones. Cllr Spires is investigating using glue to keep the mats in place. All the above has been reported to the Police.

Bradwell nuclear power station consultations. It was agreed that the **Clerk** would request a paper copy of the section concerning Bradwell on Sea. The closing date for this consultation is 22nd February 2010. **Clir Spires** attends the LCLC on this

council's behalf. This group are concerned with the decommissioning of Bradwell Power Station.

Sea Wall. Essex & South Suffolk Shoreline Management Plan (SMP).

A report. Cllr Spires had sent each Cllr a copy of his report. Some extra information had been received by Cllr Spires who explained this extra information to the Cllrs. Following a discussion it was agreed that **Cllr Spires** will draft this council's comments on the recommendation for Mayland/Maylandsea.
