#### 165. Councillor Vacancies.

The Parish Council agreed to co-opt two residents onto the council. Mr Lund and Mrs Evans wrote to the council outlining their interests and wish to serve the community. The council agree unanimously to invite both to serve on the council. The Declaration of acceptance of office was signed and witnessed by the Clerk. The Chairman then invited Cllr Lund & Cllr Evans to join the rest of the Councillors.

The vacancy on the Personnel Committee was discussed. Cllr Spires proposed Cllr Massenhove to the Personnel Committee, Cllr Hawkes seconded the proposal, all in favour, motion carried. Cllr Massenhove agreed to remain on the Finance committee until the May meeting; this will reduce the paperwork required by the bank when a signatory resigns.

### 168. Minutes of the meeting held on Tuesday 13th January 2009

Cllr Hawkes proposed accepting the minutes from 13<sup>th</sup> January meeting, Cllr Spires seconded the proposal, all in favour, motion carried. all in favour, motion carried. The minutes were signed and dated as a true record.

#### 169. Public Discussion Session & District Councillors Report.

Emergency Planning Officer Mr Gerry Richardson and Ian Holmes were unable to attend the meeting. It is hoped that they can attend in March.

The Chairman closed the meeting at 8.51pm to allow the press, public and District Councillor to address the council. The meeting was reconvened at 8.35pm

Cllr Oatham proposed moving item 171 Planning forward, Cllr Spires seconded the proposal.

For ease item 171 will be minuted in its original position.

### 170. Lawling Park Committee.

Disabled Ramp. It was reported that this can be done under permitted development providing it is done separately to the extension which will need planning permission.

It was agreed that the proposed pathway will end at the edge of the existing building and continued to the gate after the extension is completed. Only one fire door will be needed at the entrance. A further door will be required at the exit/entrance of the extension.

Extension Plans. Cllr Spires had drawn out various extension plans for the council to consider. The size layouts were obtained from the Football Association. Following a discussion Cllr Hawkes proposed accepting the 10m extension plan, Cllr Lund seconded the proposal, all in favour, motion carried.

Tree Planting. The planting of 500 whips will be carried out by volunteers on Saturday 21<sup>st</sup> February at 10am. Volunteers to meet in Katonia Avenue car park. This event has been advertised in the village, Mayland Mayl and the web site. The **Clerk** will also put a notice in the M&B.

Tennis Club. A letter and e-mail from the tennis club agreeing to the council's offer of a fee reduction for one year only has been received. For the coming season the club will pay £600 on 1<sup>st</sup> April. The council will require details of all recruitment of member's events, advertisements and the date of the open evening. It was also suggested that the club holds a stall at the school fete which is always well supported. **Clerk** to advise the club.

Katonia Avenue land dispute. The Land Registry Adjudicator found in favour of the resident. The resident's legal team are claiming costs. Following a discussion it was agreed to seek Counsel's opinion regarding appealing the decision. Cllr Oatham proposed If Counsel advised on an appeal then an appeal is lodged. If Counsel advises against an appeal then no appeal is lodged. In any event we must object to costs. Cllr Massenhove seconded the proposal, a vote was taken, 4 yes, 2 against and 2 abstained. Motion carried. **Clerk** to action.
