## 44. Minutes of the meeting held on Tuesday 10<sup>th</sup> June 2008

Cllr Spires proposed accepting the minutes, Cllr Hawkes seconded the proposal, all in favour, motion carried. The minutes were signed and dated as a true record.

No member of the public attended the meeting.

## **46. District Councillors Report**

Cllr Robinson closed the meeting at 7.34pm to allow the D.Councillors to address the council. The meeting was reconvened at 7.38pm

## 47. Lawling Park Committee.

A copy of the latest minutes has been given to each Councillor. Any questions maybe put to Cllr Spires. Cllr Spires reported that music and other events licence is required for the Lawling Park Hall. The council agreed that if any hirers wished to either sell alcohol or have adult entertainment they would need to apply for an occasional licence. **Clerk** to complete the form.

The Community Service people have been in contact and can start work this month. **Clerk** to action.

Car Park Lease/Licence. Estimate of repair costs. It was agreed that this item will be added to August agenda as Cllr Short is liaising on the council's behalf with the school governors. **Clerk** to action.

**Emergency Plan.** Cllr Short was to report in his absence this item will be added to the August agenda.

# Consideration of applications for the council to make comment to the Planning Authority.

**FUL/MAL/08/00710.** Proposed new entrance gates, pillars and walls. Sunfield Farm Highlands Hill Mayland.

**5 Objections**. Out of character with rural area, over imposing.

**TPO/MAL/08/00724. TPO 08/91** Area 1 – if necessary, remove some trees to enable erection of boundary fence, others along boundary to be coppiced to hedge. Area A

on plan – remove all trees apart from viable fruit trees and perimeter trees. Area B – coppice 50% of trees. (NB TPO only applies to trees that existed as trees at the time of serving 1991). Land SW of Nipsells Chase Mayland.

**5 Objections**. The Council strongly object to this application and request that this application goes to the Planning Committee of Maldon District Council. The reports on the wildlife/crested newts in the area were not available for the council to consider. The council also strongly suggests that the report is received and considered before MDC's Planning Committee makes a decision on this plan. The council would like to be advised of the distance the newt's travel once breeding has finished. Would they encroach on the area allocated for pigs? The council is concerned about the impact of the pigs on the environment and vicinity. The council would like confirmation that the land is still agricultural/horticultural and would like the existing class to be checked. A copy of the original TPO was not included in the application. The council agreed that they would like the TPO to be extended to cover the whole area special character of the village.

Donation request, Essex Wildlife Trust. The donation requested is £230. 25 children attended last year's event. Following a discussion Cllr Spires proposed granting EWT's request and giving the full amount. Cllr Massenhove seconded the proposal, all in favour. **Clerk** to action.

Donation request. Farleigh Hospice. Following a discussion it was agreed that healthcare was not the responsibility of parish councils. The duty of the council is service for the parishioners in Mayland and to make a donation to Farleigh Hospice was not appropriate for our funds. **Clerk** to action.

## 50. Sports & Community Centre

The date of the first meeting of this committee is Tuesday 22<sup>nd</sup> July in the Lawling Park Hall at 7.30pm.

## 51. Parks & Open Spaces.

Quotation for hedge cutting Cardnell Brothers Memorial Field. A quotation of £145 was discussed. Cllr Spires proposed accepting the quote, Cllr Hawkes seconded the proposal, all in favour, motion carried.

Quotation for erection of a bollard at Cardnell Brothers Memorial Field. The council agreed not to proceed with this purchase.

Public open spaces in Trust. It was agreed to invite Mr Paul Allan from Fields in Trust to attend a PC meeting to allow the council and residents to discuss this item fully. The council felt it was a decision that all residents should be consulted on.

Mayland Nature Reserve is becoming overgrown. The councillors agreed to meeting at the MNR on Saturday 12<sup>th</sup> July at 10am for one hour of clearing, cutting back etc., Each Cllr was asked to bring their own pruning shears and gloves. The dog bin is also in need of attention. **Clerk** to arrange with MDC for Appleton's to check out the bin and report back.

Cherry Alley. There are two trees in this area that have died and need to be removed. Cllr Oatham reported that it is a safety issue and that the owner of the trees is not known. Cllr Robinson proposed that two quotes to remove the trees under Emergency Powers would be obtained up to a maximum expenditure of £150. Cllr Hawkes seconded the proposal, all in favour. Cllr Oatham will obtain a quote from the Electricity Company who is working in Mayland clearing power lines. The Clerk will also obtain a quote from our lighting contractor.

## 52. Vandalism, Litter & Street Lighting

Councillors reported that a large amount of graffiti had been painted on the green storage unit. Painting out of the graffiti will take place as soon as possible.

#### 53. Correspondence

Maylandsea Community School. Re: Noticeboard. This board is in need of removal and possible replacement. It was previously agreed that the cost of a replacement board will be added for discussion to the budget for 2009/10. In the interim **Clir Oatham** has offered to look at the existing board and remove it if it is possible and easy to do so. The council agreed to this action. It was also agreed that the **Clerk** will advise the school accordingly.

Essex Police. Response to MPC's letter. Each Cllr has received a copy of the letter and its contents noted.

#### 54. Highways

A temporary road closure notice has been received from ECC. 5<sup>th</sup> to 6<sup>th</sup> August from 09.30 to 15.30hrs.

Hedge at Mayland Green is overgrown. Clerk to action.

A tree is protruding from a back garden onto the pavement between the village sign and Nipsells Chase. **Clir Hawkes** will ascertain which property is responsible and advise the **Clerk** who will write to the owner.

A complaint re: path between Promenade and North Drive. This land is not a public footpath and does not belong to Mayland Parish. **Clerk** to add to next agenda and to try and obtain details of ownership from Land Registry.

Verge cutting. A decision to accept MDC's agreement for our contractor to carry out the extra cuts. We are still waiting for written confirmation from MDC. Our contractor will be asked to cut the verges in the interim. **Clerk** to action.
