### 63. Apologies for Absence

Cllr Evans & Cllr Robinson. In Cllr Robinson's absence Cllr Oatham will Chair this meeting.

## 64. Minutes of the meeting held on Tuesday 11th August 2009

Following an adjustment Cllr Lund proposed accepting the minutes, Cllr Spires seconded the proposal, all in favour. The minutes were signed and dated as a true record.

#### 65. New Councillor.

The notice advertising the vacancy has been published. A decision will be made at the October meeting of this council. **Add to October agenda.** 

# 66 Code of Conduct Declaring an Interest.

Cllr Hawkes declared a personal interest in item 68 Lawling Park as her husband is employed by the council in this area.

#### 67. Public Discussion Session.

PC Ian Turner did not attend the meeting. The Vice-Chairman closed the meeting at 7.36pm to allow the press and public to address the meeting.

D.Cllr Cussen explained the procedure when MDC SE Area Planning Committee meets to discuss planning application. The council thanked D.Cllr Cussen for attending this meeting in person and explaining the issues and answering this council's questions.

The meeting was reconvened at 8.10pm

#### 68. Lawling Park.

Each Cllr has received a copy of the minutes from the August meeting. Any questions maybe put to Cllr Spires. Cllr Spires reported that the continued vandalism is costing money which has been an issue in these times when the council tried to keep the expenditure low. The goal post sockets have been set into place by members of the Mayland Village Football Club. Cllr Spires thanked them for their support and help.

CIF Notification. Following a short discussion it was agreed that this council would apply for funding towards the cost of the extension to the LPH.

Extension plan. The invitation to tender for the work has been sent to 13 possible contractors. Any further contractors will be sent the information providing they apply before the closing date of 25<sup>th</sup> September 2009

Bakersfield Drainage. Only one quotation has been received. It was agreed that when the second quotation is received this item will be added to the LPC agenda. **Clerk** to action. In the interim Cllr Oatham proposed a transfer of £7,000 from reserves into a Bakersfield improvement budget fund, Cllr Spires seconded the proposal, all in favour. **Clerk** to action.

Planning Permission required for Maylandsea Village Football Club's storage unit. A decision to apply for PP on behalf of the FC was discussed; Cllr spires proposed the council applies for PP on behalf of the football club. Cllr Lund seconded the proposal, all in favour. **Clerk** to action. The V.Chairman closed the meeting at 8.25pm to allow the member of the MVFC to approach the council and receive the planning application pack to complete (6 copies are required). This will be returned to the Clerk by on 21<sup>st</sup> September so she can finish the form. The meeting was reconvened at 8.28pm

### 69. Planning.

Emergency Plan. MDC's invite to an update meeting on 14<sup>th</sup> September 2009 will be attended by Cllr Evans.

6 Objections. The proposed development is unsympathetic in its design, scale and bulk. It would have a detrimental impact upon the existing property and neighbouring bungalows in the area. It is contrary to policy BE6 of the Maldon District Replacement Local Plan.

The council agreed that no further recommendations for improvements will be made by them until the speed reductions already proposed and agreed are carried out. It was suggested that the resident contact ECC Highways for further information regarding the improvements.

ECC. Temporary Road Closures. The various closures cover periods from September 2009 and March 2010. The information was noted.
