54. Apologies for Absence

55. Code of Conduct Declaring an Interest.

Cllr Evans declared an interest in item 59. ECC Highways response regarding platforms in The Drive.

56. Minutes of the Parish Council meeting held on 13th, 20th & 29th May 2012

Cllr Oatham proposed accepting the minutes from the meeting held on 13th May, Cllr Duncan seconded the proposal. All in favour, the minutes were signed and dated as a true record. Cllr Hawkes proposed accepting the minutes from the meeting held on 20th May, Cllr Oatham seconded the proposal. All in favour, the minutes were signed and dated as a true record.

Cllr Spires proposed accepting the minutes from the meeting held on 29th May, Cllr Duncan seconded the proposal. All in favour, the minutes were signed and dated as a true record.

57. Public Discussion Session

The Chairman closed the meeting at 7.37pm to allow the press and public to address the council. D.Cllr Mrs Penny Channer advised the council of the discrepancies between the 106 agreement and the minutes relating to that document. However, she advised the council that she would be checking the archived minutes for further information on this matter. D.Cllr Mrs Penny Channer will report back to this council as soon as she can.

The residents affected by the platforms in The Drive wrote to Highways in April and have not received a response. This council e-mailed Highways requesting a copy of their response to the resident's letter and had not had a reply. At the meeting held last year with Highways they offered to paint SLOW on the road, reduce the speed limit to 20mph, increase the area of double yellow lines between the platforms and get the SID sign reinstated. D.Cllr Mrs Penny Channer advised the council that E.C.C. Boyce is the member to contact regarding this matter. Mr R Overall is Highways Deputy Chief Executive and should also be contacted. It was reported that an extra £11 million has been set aside to repair potholes in Essex. 50,000 road defects were repaired last year. Waste collection is improving. It was reported that a pothole in Imperial Avenue is particularly bad and could this council report it to Highways. Mrs Haywood thanked the council of allowing the use of the Lawling Park Hall free of charge for Race Night and for the Picnic in the Park; the event was fantastic the weather was good. The idea of the event was to provide a free celebration for the Queen's Jubilee. However, just over £600 was raised and the organisers would like to provide a bench for the villagers to enjoy. The Chairman asked Mrs Haywood to thank all those who helped make the day the success that it was. The Chairman reconvened the meeting at 8.20pm Mr Hawkes handed keys and a letter of resignation to the Chairman.

58. Annual Parish Assembly Questions.

Dog Bins. Can we replace the dog bin at sea wall Nipsells Chase? The damage to the lid of the bin has been reported to Maldon District Council and it has been added to the list of bins waiting for repair/replacement.

Cinema. Can we have a mobile cinema in the Lawling Park Hall? This council believes this event would be better run by residents who wish to hold such an evening in the hall. The hall can be hired in the normal way.

59. Highways.

Cllrs report of any problems and actions that maybe required.

It was reported that a resident living in Tern Close is receiving visitors and goods for Teal Avenue. Could they have a sign for Tern Close? **Clerk** to contact MDC and write to the resident.

The verge at the top of Wembley Avenue/The Drive needs cutting, ask Highway Rangers. **Clerk** to action.

The Drive junction with Steeple Road, overhanging bushes causing difficulties when turning out of The Drive. **Clerk** to contact Highways.

The **Clerk** to contact Highways to get the barriers removed from outside Hardys if the road works have been completed.

ECC. Highways response to resident's letter regarding the platforms in The Drive. Currently the residents have not heard from ECC Highways. This council agreed to request the following from Highways: paint SLOW on the road, reduce the speed limit to 20mph, increase the area of double yellow lines between the platforms and get the SID sign reinstated. Clerk to action. It was also agreed that the Clerk will contact both E.C.C Councillor Boyce and Mr R Overall is Highways Deputy Chief Executive. Cllr Spires will raise this matter at the DHGPC meeting with E.C.C. Robbie Jamieson who is attending the meeting.

Local Highway Panel. A report on the changes to this panel was noted.

Nipsells Chase path. The owners of the land have erected gates across the path. E.C.C legal team who are handling the claim to get this path added to the definitive map are contacting the owner's solicitor. They are also in contact with all the residents in the unmade section of Nipsells Chase.

Audit Commission. Appointment of new external auditor for 2012/13. Noted.

Grant application from Maylandsea County Primary School, Following a discussion Cllr Spires proposed granting the school £150 for the cost of EWT's visit to the MNR. Cllr Evans seconded the proposal, all in favour **Clerk** to action.

Grant application from St Barnabas Church. It was noted that the cost of cutting the grass at the cemetery had increased. Cllr Hawkes proposed a donation of £300 towards the cost of cutting the grass; Cllr Spires seconded the proposal, all in favour. **Clerk** to action.

62. Lawling Park.

Each Cllr has received a copy of the minutes from the May LPC meeting. Any questions may be put to Cllr Spires. The application form for funding towards the cost of replacement paths has been sent to The Big Society Fund. Their decision is due in November. CCTV. It was noted that publishing photos from CCTV footage is not allowed.

Asbestos inspection. It was reported that no Asbestos was found in the building. **Clerk** to advise MDC.

Trees adjacent to Bakersfield path. It was reported that the trees/shrubs causing problems to a resident were planted by a previous occupant of the property. It was agreed that the resident can remove the shrubs to allow him to replace his fence. Community Service will be removing the leavings as soon as they can.

Hedge at Bakersfield car park. Following a discussion Cllr Hawkes proposed accepting the quotation for the work and not purchasing a hedge trimmer, no support for this proposal was found, motion failed. Cllr Spires proposed purchasing a hedge trimmer for use in various locations for a maximum expenditure of £400 + vat, Cllr Duncan seconded the proposal, a vote was taken, 3 yes 1 abstain, motion carried. **Clerk to action**

Floodlight repairs. The electrician who installed the meters noted a trip fault in one circuit it was agreed that **Clir Spires** will meet with the lighting contractor to investigate the problems prior to him carrying out the work ordered if necessary.

The path from Nipsells Chase to the layby in Steeple Road needs strimming or and weeding. It was agreed to ask Highway Rangers. **Clerk** to action.

Nature Reserve Map. It was agreed that Cllr Oatham will send a quote for the work to the Clerk.
