80. Minutes of the Parish Council meeting on 12th October 2010

Cllr Hawkes proposed accepting the minutes from the meeting held on 12th October 2010 Cllr Spires seconded the proposal, all in favour. The minutes were signed and dated as a true record.

81. Public Discussion Session.

The Chairman closed the meeting at 7.34 to allow the public to address the council. A planning application was discussed. The Chairman reconvened the meeting at 7.38pm.

82. Lawling Park.

The October meeting of the Lawling Park Committee was cancelled. Cllr Spires reported that plans to hold a clearance day are going ahead.

Security seminar. Cllr Spires attended this event held by MDC which covered home security. Many products were available at very little cost. It was agreed that an article in the Maylands Mayl would be helpful. **Clerk** to contact MDC's press officer to arrange it..

Porta cabin electrics. The electrics that are in the portacabin will be moved into the LPH extension as agreed in the specification for all the works relating to the build. Community Service. Unpaid workers will be in Mayland on Fridays from the 12th November clearing the ditch between the dog walk area and the Lawling Playing Field.

83. Planning.

SoS Statement on Energy Policy. The coalition government has launched a consultation on the revised draft National Policy Statements (NPS) on Energy. The draft Nuclear NPS lists eight sites at potentially suitable for new nuclear power stations. Bradwell is included in this list. 84. Highways.

Cllrs report the following problems:

Wembley Road. Hole in surface of road. **Clir Hawkes** will advise the Clerk of the exact location.

Nipsells Road sign at junction of Steeple Road not legible.

Gateway to village. Still fixed with black cable ties.

Sign – No vehicular access at path between Imperial Avenue and Esplanade missing. Flooding in The Drive at the junction of Katonia Avenue. Covering platform and pavements.

Give way sign at the bottom of Mayland Hill knocked down.

Clerk to action.

Traffic Calming in The Drive. Highways have the results of all of the surveys. 'The highest levels of ground-borne vibration that were recorded during the survey were 0.625 mm/sec (ppv) from traffic travelling either northbound or southbound along The Drive. This level is above the level that research shows that an average person might find unacceptable but considerably lower than the level at which cosmetic damage could occur to the property.'

Highways have agreed with the contractor to cores would be taken out of the tables to ascertain the depths of the tarmacadam. Once the results of this test have been received a meeting with be arranged with the Parish Council and the residents who live in The Drive near the platforms. A letter explaining this has been sent to all of the residents concerned. The vibrations caused by vehicles travelling over the ramps are unacceptable to the residents concerned.

Bus cage in Imperial Avenue following a discussion it was agreed to seek an alternative to the bus cage suggested by our transport representative.

Directional sign – Grange Avenue/Green Lane junction. As we cannot have a traditional finger post sign at this junction we regrettable accept the alternative suggested by ECC.

Viking Transport. Cllr Hawkes reported on the opening of the new service. A new bus has been purchased for use in the Dengie on a book and ride system. Clerk to add information to web site & noticeboard.
