

- This diary is your own personal record of what you see and hear. You should not write down something that anyone else (including your wife, husband or partner) has witnessed. They should keep their own diary. We will provide as many diary sheets as required.
- You should fill out the diary sheet as soon as possible while the incident is still fresh in your mind.
- Write down everything you see and hear in as much detail as possible. A word for word account
 is more useful than a general summary. So swear words should be included. This is more
 effective than "he used abusive behaviour". Writing such words can be upsetting but gives a
 better idea of the nature of the incident and how it has affected you.
- Try to identify the people involved in each occasion. If you don't know the full name of the
 people you are making a report about, but you know their nickname, or if they have any
 identifying characteristics (clothing, hairstyle) or if you have another way of identifying them
 please include this.
- Please make sure you sign at the bottom of each report.
- Please remember that all information you provide will be treated in the strictest confidence.
