14 Minutes of the Previous Meeting
Cllr Haywood proposed accepting the minutes from the meeting held on $30^{\text {th }}$ May 2023. Cllr Bush seconded this proposal. All in favour.

The Clerk's update on matters from the previous meeting was noted.
17 Lawling Park Hall

- Football club contract - Contract discussed. Not been an increase in several years. Cllr Chandler proposed to increase fees by 2\% per annum. Cllr Bush seconded this. All in favour. Clerk to notify football club.
- 10 Year Plan- Cllr Haywood proposed that the 10 year plan as previously discussed is accepted. Cllr Chandler seconded. All in favour.
- Higher fencing - Quote discussed to add higher fence panels behind basketball nets. It was proposed not to accept this quote and to not carry out this work.
- Floodlight bulbs - Cllr Spires proposed to purchase 9 new bulbs for the tennis court floodlights. Cllr Chandler seconded. All in favour.
- Memorial garden - Cllr Haywood to ask volunteers to tidy memorial garden. To purchase a bag of top soil for beds.
- Maintenance of Tennis Courts - A quote was discussed from ETC for the maintenance of the tennis courts. Clerk to ask them for more details and how this will affect the warranty.
- Sensory Garden - A quote was considered for installing a water pipe from the manhole to the sensory garden at a cost of $£ 800$. Cllr Spires proposed this was accepted. Cllr Bush seconded. All in favour
- Lawn Mower - Cllr Spires proposed that a new Mountfield lawn mower be purchased for the park after the old one was beyond repair. The cost agreed was £364 + vat. Cllr Chandler seconded. All in favour.
- Manhole - Cllr Spires proposed that a maximum cost of $£ 75$ be spent on repairing two manhole covers in the park. Cllr Haywood seconded. All in favour.
- Signs for Tennis Court/Bakersfield - Cllr Spires proposed accepting the quote for a sign for the tennis courts at a cost of $£ 45$ and 2 arrow signs pointing to the memorial/sensory gardens at a cost of $£ 75$ each. Cllr Chandler seconded. All in favour
