

# Minutes of the meeting of MAYLAND PARISH COUNCIL

#### **Minutes of the Previous Meeting** 35

Cllr Bush proposed accepting the minutes from the Annual Council Meeting held on 16th May 2023. Cllr Chandler seconded this proposal. All in favour.

#### **Public Discussion** 36

- A resident handed an objection to planning application 23/00544 for 8A Mill Road. Objection had four main grounds: 1) Construction nightmare – site is 500metres from Steeple Road which is only entrance to Mill Road. Heavy goods vehicles would cause many problems as only narrow road and nowhere to pass or turn round causing problems for residents. 2) Setting a precedent – It has long been the practice of the Council to refuse permission for any speculative residential development in Mill Road in order to preserve its rural nature. If this application is approved, other applications could site it as a precedent, leading to even more development. 3) Maldon and Mayland Parish Development Boundary – The site is in a sensitive rural location outside of the defined settlement boundary for Mayland Parish. Site not been identified by MDC for development and therefore the whole of Mill Road should be considered as countryside and should be protected. 4) Mayland Parish Extract -According to the Parish Extract, The Maylands, First Review, the whole of Mill Road is in a "Coastal Protection Belt". This means that no development is to be allowed except under exceptional circumstances. There are no exceptional circumstances involved here. Photographic evidence was also provided.
  - Cllr Haywood suggested residents of Mill Road who have objected, attend the area planning meeting to speak about their objections.
- Mel Clarke from the Henry Samuel Hall Committee asked if they could use the Lawling Park on 2<sup>nd</sup> July for their car show and asked if the fee could be waived as it is a community event. To discuss matter under item 40.

#### 37 **Planning**

The following applications were considered and comment to the Planning Authority agreed:-

#### • 23/00516/HOUSE PP -12180592

Extending existing outbuilding 8 Promenade, Mayland

2 Against and 4 for this proposal. Therefore, the recommendation to MDC is to raise no objection. Comment added that this building is not to be used for commercial purposes.

#### • 23/00544/FUL PP -12206568

Erection of a single 4 bedroom dwelling 8A Mill Road, Mayland

All objected to this proposal. Therefore, the recommendation to MDC is the refusal of this proposal. The following reasons are given:

- S1 Sustainable Development remote from community services and facilities, no footpath to shops
- D1 Design Quality and Build Environment Design incompatible with rural character, wrap around someone else's property
- T2 Accessibility Inaccessible by a range of transport. Application is on a single unmade road with inadequate road access. Danger to pedestrians walking down this road.

## 40 Lawling Park Committee including Bakersfield, Lawling Playing Field & Dog Walk Area

- Park Vandalism Footprints have been removed in the small children's playground causing a trip hazard. Cllr Spires proposed that a quote to repair these be accepted at a cost of £1165 + vat. Cllr Bush seconded this. All in favour
  Two youths had graffitied the youth shelter which has had to be painted over. CCTV footage of both incidents has been viewed and been reported to the police.
- Charges for HSH Committee Cllr Spires proposed that the HSH Committee can use the
  hall and field with no charge as this is a community event. Cllr Oatham seconded. All in
  favour. Mel Clarke thanked the council.
   Cllr Haywood proposed that the land by the bollards in Bakersfield car park be levelled
  up. Cllr Chandler seconded this. All in favour. Clerk to ask Ideal Landscapes to do this.
- Closing park Confirmation that only the football field will be closed off during the car show as a safety measure and that the playground would remain open. Cllr Spires proposed these measures. Cllr Bush seconded. All in favour.
- Raffle Prize Cllr Haywood proposed that two hours hall hire be donated to Latchingdon Primary school as requested. Cllr Chandler seconded this. All in favour.
- Hall use rules Hall rules will be amended to include No balls or scooters allowed in the hall
- Sensory Path Cllr Bush proposed that the new concrete path for the sensory garden will be painted in place of shingle being added. Cllr Haywood seconded. All in favour. To look into getting electricity and water to this garden.
- Contact sign for tennis courts Cllr Spires proposed that a sign be fitted to the tennis
  courts with contact details for hiring courts. Cllr Haywood seconded. All in favour. Sign
  also needed to direct people to Memorial garden/Sensory garden.
- Community Hall Cllr Oatham proposed that quotes be obtained to build a community hall in the Lawling park. Loans can be obtained from the public loan board.

#### 41 Village Environment

- Rear of Whitefield Court A quote was considered to clear the rear of Whitefield Court but there were discussions over what was needed. Cllr Haywood to look and then discuss at next meeting.
- Bakersfield car park hedge Cllr Chandler proposed that a quote be accepted to reduce the height of the hedge adjacent to Bakersfield Car park at a cost of £930. Cllr Down seconded. All in favour. To confirm that the hedge will be no lower than eight feet.
- Allotments A possible piece of land has become available for allotments. To make further enquiries on costs. Grants available.
- Road Closure A letter is required from the clerk to give permission for the road to be closed for the Christmas market in November. Cllr Haywood proposed that this is done. Cllr Chandler seconded. All in favour.
- Flytipping Cllr Haywood proposed that a maximum budget of £150 be spent to remove sofas in the nature reserve. Cllr Spires seconded this. All in favour.

#### 42 CCTV

 Cllr Haywood proposed that the Vodafone contract for the new camera at Bakersfield be changed to a yearly contract at a cost of £6 per month. Cllr Chandler seconded. All in favour.

#### 43 Neighbourhood Planning Committee

Cllr Spires updated the council and read out communication from Troy Planning and Code Development planners who have requested a meeting in the Lawling hall to present their proposals. The Neighbourhood Planning Committee resolved to not allow this public meeting to take place until the plan is made.

A zoom meeting with Troy Planning is due to take place this week.

Expenditure of grants and allocated monies for Troy Planning given to all councillors.
