

Minutes of the meeting of MAYLAND PARISH COUNCIL held in the Lawling Park Hall on Tuesday 11th July 2023 at 7.00 p.m.

47 Declaration of Interests Cllr Morris declared an interest in item 57

48 Minutes of the Previous Meeting

Cllr Chandler proposed accepting the minutes from the Parish Council Meeting held on 13th June 2023. Cllr Spires seconded this proposal. All in favour.

49 Public Discussion

- A lot of residents attended the meeting to oppose the planning application 23/00652/OUTM for permission to build 57 dwellings on the land at the junction of Steeple Road and Mill Road, Mayland. A spokesman put the following points across:
 - a) Infrastructure Doctors, schools all full
 - b) Roads Mill Road crumbling, too narrow, no pavement, poor visibility
 - c) Development Boundary plans outside boundary, not part of six year plan
 - d) Set a precedent if granted permission
 - e) Demolition on land started already
 - f) Sewage works at maximum capacity already
 - g) Connectivity- site must be able to connect with services which it does not

50 Planning

The following applications were considered and comment to the Planning Authority agreed:-

• 23/00399/FUL PP -12083445

To form a base with an erection of a mobile home to the rear garden Land at 7 Mill Road, Mayland

1 Against and 3 For this proposal. Three abstained from voting. Therefore, the recommendation to MDC is to raise no objection. Comment added that the mobile home should have wheels.

• 23/00454/FUL PP -12104641

Extension to existing summerhouse in rear garden to provide annex accommodation. Wrington 27 Imperial Avenue, Mayland

All objected to this proposal. Therefore, the recommendation to MDC is the refusal of this proposal. The following reasons are given:

 D1 Design Quality and Build Environment – Design of summerhouse is too high and too close to neighbouring boundary which could have a detrimental impact upon the neighbouring residents.

Outline permission with all matters reserved for up to 57 dwellings Land at Junction of Steeple Road and Mill Road, Mayland
