- Cllr Haywood proposed that these payments be accepted. Cllr Spires seconded this proposal. All in favour.
- All councillors received a copy of bank reconciliation for September. Cllr Spires verified and signed it.
- Councillors were sent the recent salary increases awarded by National Joint Council
  which have been backdated to 1<sup>st</sup> April 2023. This increase applies to the clerk's salary
  and a letter of confirmation has been sent.
- The Precept was discussed. Cllr Spires requested a copy of the budget for all councillors to consider and this will be discussed further in the December Parish Meeting.

# 101 New Councillor Application

 An application was considered from John Emmett who has attended three Parish Council Meetings. He introduced himself to the Council. Cllr Oatham proposed that he be coopted onto the Parish Council. Cllr Spires seconded this. All in favour. Clerk to ensure he signs a declaration of acceptance of office form.

#### 102 Lawling Park Committee including Bakersfield, Lawling Playing Field & Dog Walk Area

- Car Park Repairs Cllr Oatham proposed that a budget of £2,000 be spent on repairs to the paths in the Bakersfield Car Park. Cllr Spires seconded. All in favour. Clerk to compare quotes to make sure like for like.
- Poisonous shrubs A quote was considered to remove an area around the Lawling
  Park where some poisonous shrubs were growing. It was understood that these have
  now been removed and the area would be checked regularly.
- Circus Cllr Chandler proposed that we agree to a small circus coming to the park 10th-14th July 2024. Cllr Spires seconded this. All in favour. A poster would be provided and details to residents to be forwarded nearer the time.
- Spare Parts A quote to purchase spare parts for the small children's playground was considered. Cllr Spires proposed that this be accepted at a cost of £234.74. Cllr Haywood seconded. All in favour
- Bench After discussion with resident, a bench was considered for the Bakersfield Park.
   Cllr Spires proposed that this be added to next year's budget for consideration by the Lawling Park Committee.
- **Decorations** Cllr Haywood proposed that decorations are purchased for the hall, boat and for other events in the village at a cost of £200. Cllr Spires seconded. All in favour
- **Plaques** Cllr Haywood proposed that the council purchase a plaque for the memorial wall for both Andy Duncan and Don Abernethy. Cllr Spires seconded. All in favour.
- **Floodlights** Cllr Haywood proposed that the charge for the floodlights being used in the field was to be set at £5 a visit. All in favour.

#### 103 Village Environment

- Streetlights A quote was considered to replace the bulbs in streetlights along Cherry Alley and outside Henry Samuel Hall. Cllr Chandler proposed that the sodium bulbs be used at a total cost of £278. Cllr Bush seconded. All in favour.
- Sea Wall Path A report from a resident informing us of the condition of the sea wall paths was discussed. Clerk has contacted the Environment department at MDC to see what they suggest. Bushes also need trimming along this path.

# **104 CCTV**

 Three cameras are not working. Clerk has been in contact with Enhanced Security. Cllr Oatham to ask another contractor to compare costs.

# 105 Neighbourhood Planning Committee

- Cllr Spires updated the council on the recent Neighbourhood Plan consultation
